AN ORDINANCE AMENDING ORDINANCES 11-07 AND 13-25 AND RELATING TO AUTHORIZING THE SALE OF MALT BEVERAGES, WINE, AND DISTILLED SPIRITS BY THE DRINK AND PACKAGE, THE SAMPLING OF WINE AT ANY LICENSED KENTUCKY SMALL FARM WINERY, AND THE SAMPLING OF DISTILLED SPIRITS AT ANY LICENSED KENTUCKY DISTILLERY ON SUNDAYS IN BULLITT COUNTY, KENTUCKY.

WHEREAS, KRS § 244.290(3)(b) authorizes a fiscal court to allow for Sunday sales of distilled spirits and wine at licensed premises; and

WHEREAS, KRS § 244.480(4) authorizes a fiscal court to allow for Sunday sales of maltbeverages at licensed premises; and

WHEREAS, KRS § 243.155 allows licensed small farm wineries to sell wine that they have bottled or that have been bottled by another small farm winery and to serve complimentary samples of wine that they have produced; and

WHEREAS, KRS 243.0305 allows for sales of souvenir liquor packages by distilleries that have obtained a souvenir retail liquor license; and

WHEREAS, KRS 244.050 allows distilleries that have obtained a souvenir retail liquor license to provide samples to visitors; and

WHEREAS, fiscal courts in Kentucky are authorized to enact legislation to promote and support the local tourism industry;

NOW THEREFORE BE IT ORDAINED by the Fiscal Court of the County of Bullitt, Commonwealth of Kentucky, as follows:

SECTION 1: SALE AND SAMPLES OF DISTILLED SPIRITS, WINE, AND MALT BEVERAGES BY THE DRINK AND PACKAGE

A. Any premises licensed to sell distilled spirits, wine, or malt beverages by the drink or by the package may do so in accordance with the laws of the Commonwealth of Kentucky.

B. Any premises licensed to serve complimentary samples of distilled spirits, wine, or malt beverages may do so in accordance with the laws of the Commonwealth of Kentucky.

C. For Monday through Saturday of each week, the sales referenced in subsection A and the samples referenced in subsection B shall be limited, if at all, only by Kentucky Revised Statute or regulation of the Department for Alcoholic Beverage Control.

D. For Sunday, the sales referenced in subsection A and the samples referenced in subsection B shall take place only from 12 p.m. until 10 p.m.

SECTION 2: SEVERABILITY

Should any section, subdivisions, sentence or clause of this ordinance be held unconstitutional or invalid for any reason by any court of competent jurisdiction, then such portion shall be deemed a separate, distinct and independent provision and such holdings shall not affect the validity of the remaining portions of this ordinance.

SECTION 3: INCONSISTENT ORDINANCES REPEALED

All ordinances or parts thereof in conflict with the provisions of this ordinance are hereby

repealed, and the duration of this ordinance shall be until repealed, modified or amended

according to law.

COMMONWEALTH OF KENTUCKY BULLITT COUNTY ORDINANCE NO. 14-04

AN ORDINANCE AMENDING ORDINANCE 83-03 REAFFIRMING AND IMPOSING A LICENSE FEE UPON CERTAIN BUSINESSES, OCCUPATIONS, AND TRADES TRAFFICKING IN PERMITTED ALCOHOLIC BEVERAGES WITHIN BULLITT COUNTY.

WHEREAS, KRS § 243.060 allows fiscal courts to impose license fees upon any business, occupation or trade conducted in Bullitt County and engaged in the lawful trafficking of alcoholic beverages.

NOW, THEREFORE, BE IT ORDAINED by the Fiscal Court of the County of Bullitt, Commonwealth of Kentucky, as follows:

Section 1: Each person engaged for compensation in any trade, occupation or business within Bullitt County, Kentucky, including all persons located within any municipality and which are also engaged in the lawful trafficking or sale of alcoholic beverages as licensed or permitted by the Commonwealth of Kentucky pursuant to KRS Chapter 243 shall procure from the county clerk an annual license and shall pay to the county a license fee for such license according to the schedule set out in Section 5 of this Ordinance.

Section 2: As used in this Ordinance, the word "person" shall include corporations, joint stock companies, partnerships, associations, proprietorships, individuals or any other legal entity.

Section 3: The revenue derived from the license fees herein levied shall be paid into and become a part of the general fund of the county.

Section 4: The license tax herein levied shall be due on the first day of July, in each year, unless otherwise stated. Persons desiring to operate for only part of a license year after July 1, of any particular year, shall be permitted to pay a pro-rated fee equal to as many twelfths in the annual license fee as there are in the calendar months remaining in the license year, including the month in which the license is granted. A license fee shall be deemed delinquent if not paid within 30 days after same becomes due and a penalty of 20% of the amount of the fee shall be added thereto upon delinquency, with an additional 20% penalty being added for each month of continuing delinquency thereafter.

Section 5: The following fees are hereby fixed, per annum:

B.	Quota Retail Drink License	400.00
C.	Nonquota Type 2 Retail Drink License	300.00

D.	Nonquota Type 3 Retail Drink License	100.00
E.	Nonquota retail malt beverage package license	200.00
F.	Nonquota Type 4 Retail Malt Beverage Drink License	
G.	Special Temporary License, per day	25.00
	(not to exceed \$166.66 per event)	
H.	Limited Restaurant License	400.00
1.	Limited Golf Course License	400.00

Section 6: Any amount paid to any city within Bullitt County as a license fee for the same privilege for the same year may be credited against the County license fee.

Section 7: In determining which category or categories of licenses a person may be required to acquire, the classification provisions of the Kentucky Revised Statutes Chapter 243 and the regulations promulgated thereunder by the Kentucky Alcohol Control Board shall apply.

Section 8: This Ordinance shall take effect upon publication and pro-rating of license fees shall begin with and include the month of April, 2014.

Section 9: If any provision of this ordinance is deemed unconstitutional or invalid for any reason by a court of competent jurisdiction, such provision shall be deemed a separate provision and such shall not affect the validity of the remaining provisions of this ordinance.

Section 10: All ordinances and resolutions, to the extent they are inconsistent herewith, are hereby repealed.
