ROBERTSON COUNTY ORDINANCE

16-02

Whereas due to a petition for election of having alcohol sales in Robertson County was properly presented to the Robertson County Board of Elections Chairman and Robertson County Clerk, and wherein the Robertson County Judge/Executive approved the petition as sufficient to bring the issue to election; and whereas the County of Robertson, State of Kentucky, held a duly authorized election on August 30, 2016, after the Robertson County Sheriff duly advertised the election in all five precincts, with at least five advertisements in each voting district, and wherein, the final results were in favor of alcohol sales in Robertson County; wherein, thereafter the Robertson County Clerk certified the results on September 1, 2016, and said election results were found to be in compliance by the Robertson County Grand Jury in September 2016, and wherein the Robertson County Fiscal Court is desirous of establishing an ordinance regarding alcohol license fees, hours of sales and days of sales, and wherein the following are the established license application requirements, license fees for each alcohol license, days of sale, and hours of sale.

WHEREAS; THE ROBERTSON COUNTY FISCAL COURT HEREBY ESTABLISHES THE FOLLOWING ALCOHOL LICENSE APPLICATION REQUIRMENTS, ALCOHOL LICENSE FEES FOR EACH ALCOHOL LICENSE, DAYS OF ALCOHOL SALES, AND HOURS OF SALE:

A) LICENSE APPLICATION REQUIRMENTS

- The Robertson County Fiscal Court hereby establishes that any person desiring an alcohol license as authorized under the Kentucky Revised Statutes, Chapter 243, hereby requires that the applicant execute an alcohol license application that can be obtained in the Robertson County Judge/Executive's Office, pay the license fee and obtain a county alcohol license permit, as approved by the County administrator which is the Robertson County Fiscal Court voting consensus, prior to the applicant applying for approval of licensure from the Kentucky Alcohol Beverage Commission as established in Kentucky Revised Statute, 243.
- ii) Any applicant must meet all requirements of Kentucky Revised Statute 243.100.
